- b. \$5.00 increase to banquet tickets was sufficient to cover cost of meal, door prizes and cash back at door.
 - i. Note* If you purchase a ticket for the banquet and do not attend, the \$10 cash back is not given back as we had to consider the cost of your meal.
- 11. More Friendly Reminders for captains to share with their teams:
 - a. Facebook and web page is available for news and updates please check these places prior to emailing or texting the executive questions (i.e., schedule, starting times, etc.)
 - b. Please ensure that you communicate with your teammates following correspondence from the executive, so they do not ask us directly.
 - c. Absolutely no outside food or drink while playing (unless authorized by venue or by special request for birthday, Christmas, etc... no timmies, no water bottles, energy drinks, etc.). It is up to the team captains to monitor this and if it becomes an issue, we may have to suspend the player and or team from the league.
 - d. A purchase must be made at the venue you are visiting if you wish to play.
 - e. Common Courtesy and respect is mandatory for all players and guests. If an issue arises during play, stop the match, report to your team captain and they will determine how to proceed. Team captains: politely and discreetly discuss the issue to come up with an agreement/settlement of the issue. If an issue cannot be settled, please do not engage in an argument walk away and any non-settled issues are to be forwarded via written comments to the executive. If players continue to engage in an argument that is deemed disruptive for the league and/or the venue, all involved will be suspended for the following week while the executive determine if further action is required.
 - i. On this note...if a team or player is playing music that you deem is too loud, politely as the team captain to tone it down. Team captain, please do not give the person requesting this attitude or grief.
 - ii. Loudness and swearing see above. People across the room should not be able to hear you. Your tone should be at a level that the group you are currently playing with/against can hear.
 - iii. Try to avoid sudden shouts (whether you are happy or angry with your darts we all do it). This action could cause a distraction for someone on another board that is taking a finishing shot, etc.
 - iv. Please respect other players, patrons, and staff of the venue. Not all venues are a legion with lots of boards and ideal lighting. There will likely be other people in the space (pool players, other dart leagues, shuffleboard, regulars, diners,

- etc.) Please check with the home team captains to determine if there are assigned boards or seating for the respective teams.
- 12. Replacement boards and supplies for each venue must be discussed between the team captains and the venue. If the team is paying all or part, make sure this is divided equally between all leagues that play in that space regularly.
- 13. Banquet at the Polish Legion do this again on a Sunday? Feedback from last year? Suggestions for improvement?
 - a. Tentative date is Sunday May 26th to allow sufficient time to prepare between playoffs and the banquet for trophies, etc
 - i. Any suggestions for yearend prizes other than trophies?
- 14. Youth Darts \$200 annual donation?
- 15. New Business???
 - a. Play offs (uneven division) we have worked out a round robin schedule in the event that there is a group of 5 in any one division during playoffs.
 - b. # of games that spares need to play to be eligible for playoffs? this was brought up briefly, but never decided on. Executive met on September 18th and voted on 3 games.
 - c. tournament discussion possibly a better turnout now that captains know there is a time limit and the tournaments must end by 11:00. Was also suggested to potentially order in food or ask the KWNA staff to make more sandwiches on these dates for players that may not have time for dinner prior to tournament start time
 - d. Blair mentioned that he may have extra players for any teams that need players. Dan L said the same thing (both players would like to be on the same team)
 - e. Portuguese Club looking into mounting cabinets on the wall and getting rid of the portables. Players don't like the portables they are wobbly and tripping hazard.
 - f. Banquet date will remain on a Sunday as this was well received. Suggested date was may 26th and most captains said this should work. Follow up to discuss with Polish Legion's availability
 - g. Start date will be on October 16
 - h. Contact Polish Legion to discuss boards and lighting Megan mentioned that the backroom has been renovated, but executive will need to check out space
 - After the meeting, Steve suggested that we increase the number of door prizes we have \$360 from unclaimed donations. Suggested smaller amount for door prizes. (Brian G had also mentioned looking for sponsors to donate door prizes)

- b. November 13 blind draw tournament (also a federal holiday in honour of Remembrance Day)
